

# HEAD GAMES - A TRIBUTE TO FOREIGNER

## PERFORMANCE RIDER

- **Client Responsibilities**

- The Client agrees to provide or arrange with third parties for the following:
  - **Power & Stage Requirements**
    - Two (2) separate 115–120V, 15-amp power circuits within 25 feet of the band's setup location.
    - A minimum of 125 square feet of performance space.
    - Clear access for load-in, setup, and soundcheck at least 3 hours prior to performance start time.
  - **Production**
    - All sound and lighting equipment, including qualified staff to operate it.
    - Approvals and permits for amplified sound from all relevant local authorities.
    - Note: Cancellation or disruption by local authorities does not release the Client from payment obligations.
    - Show Intro Audio Playback: Venue agrees to confirm in advance whether the in-house sound system and engineer can accommodate playback of a band-provided audio file (WAV or MP3 format) as a show intro through the house PA. Venue shall also specify any requirements for file delivery (e.g., format, device, or submission method) no later than five (5) days prior to the performance date.
  - **Backline**
    - If required, the Band will provide a backline equipment list as part of this rider.
  - **Hospitality**
    - Water and non-alcoholic beverages for all band members.
    - Food provided at no cost to the Band.
    - A clean, private greenroom or dressing room near the stage area.
    - A 4-top reserved table with a clear view of the stage.
  - **Logistics**
    - Adequate parking and access for band vehicles.
    - Advance Information Requirement: Venue agrees to provide the following details no later than five (5) days prior to the performance date: designated load-in time, specific parking and load-in location/instructions, scheduled soundcheck time, and primary contact information (name and phone number) for the production manager and/or front-of-house engineer.
  - **Merchandise**
    - A well-lit table and space for merchandise sales.
    - No venue commission on merchandise sales unless previously agreed upon in writing.
  - **Meal Buyout**
    - If food cannot be provided, a meal buyout of \$25 per band member is requested.
  - **Cancellation Policy**
    - In the event of cancellation due to weather, illness, or force majeure, the Client agrees to pay 100% of the agreed performance fee unless otherwise negotiated.
  - **Payment Terms**
    - A 50% deposit is due within 30 days of signing the contract.
    - Remaining balance is due on the day of the performance via [cash, check, PayPal, Venmo, etc.].

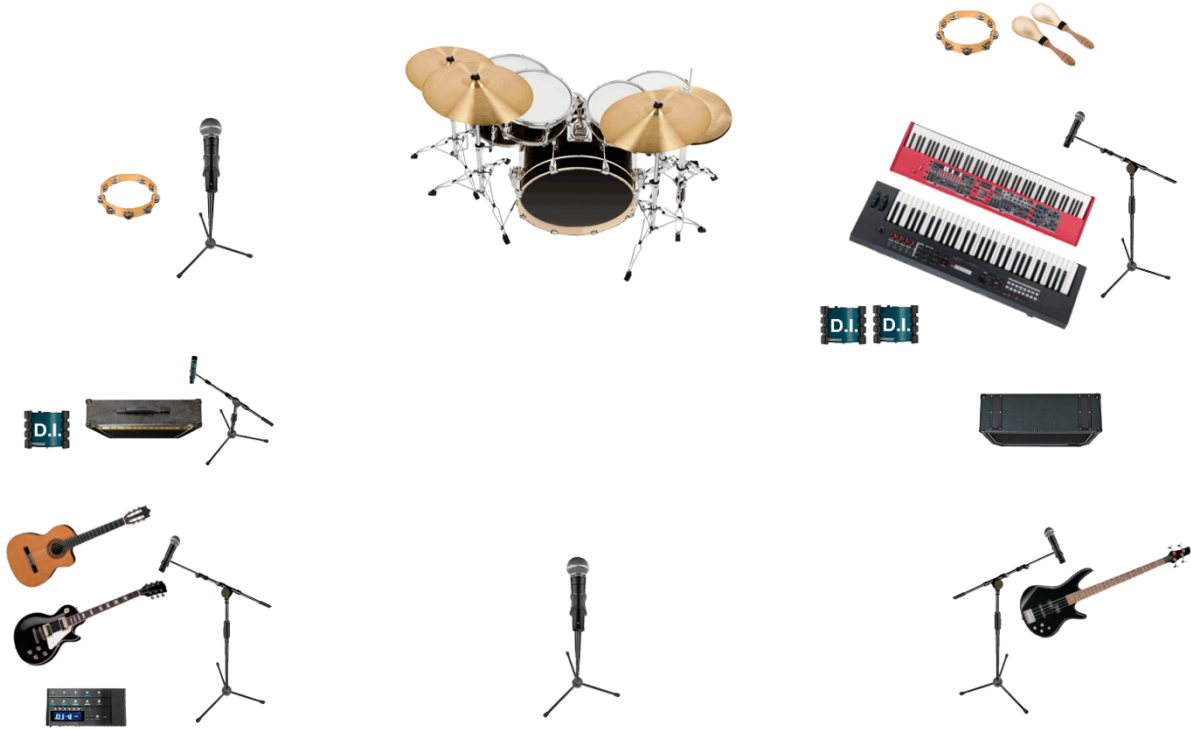
- **Promotional Requirements**

  - Band name and logo (if provided in time for pricing)
